On 05-01-08 at approximately 1057 hours, I responded to the above location in reference to suicide. Upon arrival, I made contact with (C-1) Blanche Palfrey in the carport of the above location. Blanche was visibly shaken and advised she had located her daughter, (Z-1) Debra Palfrey, motionless, hanging in a shed. (L-3) Ofc. Acevedo was also on- scene and began to speak with Blanche concerning the incident.

I made my way to the rear of the carport where the shed was located. (Z-5) Lt. Parker and (Z-5) M. Glodfeder of the Tarpon Springs Fire Department were already on scene and tending to Palfrey in the shed.

I observed Palfrey hanging from a red/white, nylon type rope affixed to an "L" bracket directly above her. The rope was tied around Palfrey's neck, and she was positioned facing the rear wall of the shed in front of a window.

Lt. Parker pronounced Palfrey deceased at 1101 hours.

At this point, I made contact with (L-2) Sgt. Hill and (L-1) Cpl. Van Schaick who were on scene. I briefed Sgt. Hill on the incident, and he contacted (L-4) Det. Sgt. Faugno to respond.

The scene was secured at 1102 hours by (L-13) Ofc. D. Craft, who taped off the area. Cpl. Van Schaick began a crime scene log. For further detail on Cpl. Van Schaick's involvement see his supplement report.

Det. Sgt. Faugno, Det. Cpl. Brockew, Det. Wireman, and Det. Peters arrived on scene and took over the investigation. For further detail see their supplements.

I again made contact with Blanche, who was now inside her residence being comforted by eighbors. (Z-2) Joyce Baker, (Z-3) Donald Edward, and (Z-4) Sarah Edwards stayed in the front room of Blanche's residence with her during the investigation.

Blanche stated she had last seen Debra at approximately 1000 hours, when Debra told her she did not feel well and was going to take a nap. Blanche later went outside to get some air. At that time, she noticed that her three wheeled tricycle had been moved out of the shed. Blanche then called out to Debra, to tell her about the tricycle. Debra did not answer. Blanche then went to Debra's bedroom and found it empty. She then went out to the shed and found Debra hanging motionless. Blanche called 911 for assistance.

Blanche said that Debra had not made any statements recently in reference to wanting to harm herself. She did advise she was upset over a recent court conviction. Blanche described Debra as healthy and advised she did not know of any medical ailments or medications she was taking. Blanche advised Debra lived in California but had been staying with her off and on for a month.

Blanche showed me a spare bedroom at the rear of the home where Debra had been sleeping. I located luggage on the floor, a binder on the dresser, and two yellow pieces of paper on a nightstand. The papers appeared to be suicide notes written to Debra's mother and sister. I informed Cpl. Brockew of the findings.

At approximately 1210 hours, I took over the crime scene log from Cpl. Van Schaick and had no further involvement in the investigation. I later entered the original log into evidence. No further action taken.

Due to Blanches' emotionally state I escorted her inside of her residence to allow her to sit down. At this time, Blanche provided me with her personal information. This information was then passed on to Ofc. M. Geer (Primary Officer).

No further action at this time.

I was later advised by Sgt. T. Hill to return to the scene in order to provide crime scene security. Upon my arrival, I took position on the eastside of the home until the T.S.P.D. investigation was completed.

No further action taken.

On this date, I responded to the above listed location in reference to an apparent suicide by hanging. Upon my arrival, Tarpon Springs Fire Rescue and Sunstar personnel had just arrived on scene. Officer Acevedo arrived with me. Tarpon Springs Fire Rescue Lt. Parker and Paramedic Goldfeder were checking the vitals to a white female hanging in the storage shed located at the north end of the sally port style driveway of the residence. The white female, later identified as Deborah J. Palfrey, was pronounced deceased by Parker and Goldfeder.

Deborah's mother, Blanche E. Palfrey, was standing by the shed, holding on to a support post to the sally port. She was very emotional and was being consoled by neighbors of the complex. Lt. Parker attempted to get Blanche to go inside the residence with negative results. Officers Geer and Craft arrived on scene. I asked Officer Acevedo to make another attempt to get Blanche to go inside her residence and to accompany her to provide emotional support. Blanche responded to Acevedo's request. Sgt. Hill arrived on scene.

Officer Craft secured the crime scene at the direction of Sgt. Hill. I initiated a crime scene log. Detective Sgt. Faugno, Detective Cpl. Brockew, Detective Peters and Wireman all arrived on scene within minutes of each other. The scene was then released to Detective Sgt. Faugno. While the detectives were gathering all of the preliminary investigative information, I noticed a 2008 Chevrolet, displaying Florida registration plate: 585KDJ, parked to the immediate west of the incident location, adjacent to it. A registration check of the aforementioned vehicle plate revealed it belonged to Enterprise Leasing Company. I then called our local office to see who had leased the vehicle. They advised the vehicle had been leased to the deceased from their Tarpon Springs office. I then relayed this information to Faugno. I then secured the vehicle with crime scene tape.

Captain Young arrived on scene. I released the crime scene log to Officer Geer at approximately 12:10pm. I have no more involvement in the case.

NARRATIVE:

I made contact with Blanche Palfrey inside her residence. Blanche was in the company of her neighbors. (Z-2) Joyce Baker, (Z-3) Donald Edward, and (Z-4) Sarah Edwards.

Blanche stated at approximately 1000 hrs; she was having a cup of coffee when (Z1) Debra Palfrey came into the sitting room. Debra sat down and they began talking about general things. Debra told her she did not feel good and was going to take a nap. Blanche later went outside to get some air. At that time she noticed that her three wheel tricycle had been moved out of her shed. Blanche then called out to Debra, to tell her about the tricycle. Debra did not answer. Blanche then went to Debra's bedroom and found it empty. She then went out to the shed and located Debra hanging motionless. Blanche said that she had been worried about Debra, especially for the last four days, Blanche did not have any specific reason for feeling this way. Debra had not made any statements indicating that she wanted to harm herself. Blanche advised me that Debra had gotten legal papers from her lawyer on 4/30/08, papers that she had to fill out prior to reporting to jail. This had made Debra depressed for a little while, but according to Blanche later Debra seemed fine. Blanche and Debra had the night before watched old video's of Debra's deceased father. Blanche described Debra as healthy and advised she did not know of any medical ailments or medications she was taking.

Narrative: On 05/02/08 I made telephone contact with (Z1) Lt. Joe Johnson of the Howard County Police Department in Maryland in reference to obtaining a copy of the police report and copies of evidentiary materials detailing Brandy Britton's suicide. Ms. Britton had been in the employ of Ms. Palfrey prior to her arrest for prostitution. Lt. Johnson faxed me a copy of the report written by case officer (Z2) Det. Cpl. Aaron Dombrowsky. While conversing with Lt. Johnson via telephone he advised me that Ms. Britton had hanged herself with a scarf strewn over her bedroom door. He advised that the scarf was tied around her neck with a double knot, and the scarf was secured over the door via a single knot. This was confirmed upon receipt and review of Det. Cpl. Dombrowsky's report. Ms. Britton's method of hanging differs from the manner in which Ms. Palfrey hanged herself (see case Det. Cpl. S. Brockew's report for further explanation).

On 05/05/08 I made contact with (Z3) Jeff Timon at the Pinellas County Medical Examiner's Office to retrieve evidence removed from Ms. Palfrey's person during the autopsy. Mr. Timon removed the property from a secured evidence locker in my presence and relinquished custody to me after I signed a receipt detailing that the property had been released. The contents of the package (a sealed brown paper bag) are as follows: Two hair barrettes, one brown, one black, and one length of red and white nylon rope. These items were transported to TSPD where I gave over custody of them to case Det. S. Brockew. These items were accompanied by a TSPD property sheet detailing the listed items.

On 05/06/08 I spoke with (Z4) Dan Moldea in reference to his statements that Ms. Palfrey had commented to him that she had contemplated suicide. Mr. Moldea stated that he was having regular meetings with Ms. Palfrey last summer to discuss her pending court case. He stated that these interviews occurred in July and August of 2007 (this would be prior to Ms. Palfrey's guilty convictions). Mr. Moldea stated that at the time if these interviews, Ms. Palfrey was under the impression that her court proceedings would produce a guilty verdict. He stated that because Ms. Palfrey believed this, she displayed a marked depression in her demeanor. Mr. Moldea stated that the purpose of these meetings was to discuss and put together a book proposal for Ms. Palfrey (these meetings and


discussions occurred via telephone, although they did meet on several occasions). Mr. Moldea stated that during one of their conversations, Ms. Palfrey stated to him three times that she was contemplating suicide. According to Mr. Moldea, there were no specific comments as it relates to the manner of suicide Ms. Palfrey would use. Mr. Maldea stated that these conversations centered on her prior incarceration and her reluctance to serve prison time again. Mr. Moldea advised that Ms. Palfrey explained to him that her first time in prison was very traumatic, and that she developed an illness which caused her much stress. Ms. Palfrey described the illness as severe enough to occasionally impair her vision. Mr. Moldea advised that her statements worried him enough that he expressed his concerns to others, including Ms. Palfrey's attorney at the time, and (Z5) James Grady. Mr. Moldea had introduced Ms. Palfrey to Mr. Grady, a novelist living in Washington D.C., late in 2007 in reference to obtaining more assistance for her in writing her book.

Mr. Moldea also informed me that Ms. Palfrey was stressed to the point that she fired her first two attorneys over conflicts involving her numerous media appearances. He stated that at no point did Ms. Palfrey state to him, or infer in any manner, that she believed someone intended to do her harm. He stated that she was simply depressed over her looming legal troubles, fearing she would lose all her assets and serve time in prison. Mr. Moldea advised me that he also had several e-mail conversations with Ms. Palfrey over the course of time they were speaking to each other. He stated that she was always very quick to respond to his e-mail inquiries. He stated the last time he saw her in person was April 11th, 2008, when he met her for lunch at the Uptown Café on Connecticut Ave. in Washington. This meeting occurred just days prior to Ms. Palfrey being found guilty at her trial. Mr. Moldea stated that during this lunch, Ms. Palfrey was very upbeat and positive in attitude because recent news articles had appeared to be in her favor. Mr. Moldea stated that at the time they met for lunch, Ms. Palfrey believed she would truly be found not guilty. She advised Mr. Moldea at that time that she and her attorney had decided to not even put on a defense during her trial because she felt none was warranted. Mr. Moldea advised that his last e-mail to Ms. Palfrey was on April 23rd. He stated that Ms. Palfrey did not reply to this e-mail, in which he inquired after her well being (he forwarded me a copy of this inquiry via e-mail). Mr. Moldea stated that he still had a copy of the book proposal they were putting together. He sent me a copy, which included comments Ms. Palfrey made regarding her suicidal thoughts. Mr. Moldea advised that Ms. Palfrey had cooperated with the book proposal, adding that she had reviewed what had been written to date, and approved of the proposals contents. Page thirty-three (33) of the document stated that "Seemingly overwhelmed with problems that resulted from the raid of her home, Jeane, who also considered suicide in her latest ordeal, received a message from Montgomery Blair Sibley, a D.C. attorney who specialized in forfeiture and seizure cases." Page thirty-four (34) of the document contains a quote that is attributed to Ms. Palfrey herself. This statement reads as follows: "I considered suicide after my arrests. Every girl in similar situations who emailed me sympathy-the Vegas Madam, the High-Tech Madam-Have all considered suicide. No one knows what it's like to be in this position. This is like being in a Kafka novel." A copy of the book proposal and Mr. Moldea's last e-mail were forwarded to case Det. Cpl. S. Brockew.

I spoke with Mr. Grady via telephone on 05/06/08. He advised that Mr. Moldea introduced Ms. Palfrey to him for assistance in obtaining a book deal for her story. Mr. Grady, a published fiction novelist, stated that when he met with Ms. Palfrey in December 2007, she was still very depressed over her current financial and legal situations. Mr. Grady stated that while Ms. Palfrey never made any comments to him about suicide, she was very depressed. Ms. Palfrey never mentioned to Mr. Grady that she feared any sort of harmful retribution to her person. I attempted to contact (Z5) Alex Jones, a radio talk show host who interviewed Ms. Palfrey, in order to conduct an interview with him in reference to her statements about never intending to commit suicide. There is a recorded statement made by Ms. Palfrey on Mr. Jones' radio show in which she expressed that she was not intending to commit suicide. Her comments came in the form of an answer to a specific question posed by Mr. Jones about her intentions to commit suicide. This question was asked in context of the discussion about one of Ms. Palfrey's former escorts committing suicide (Brandy Britton). I attempted contact Mr. Jones on three separate occasions, once via telephone (I called the number provided on Mr. Jones website, 512-291-5750) leaving a message. I then sent two separate e-mail requests, which were unanswered. Due to not speaking with Mr. Jones I was unable to verify how many times he actually spoke with Ms. Palfrey, or if she had made any other comments off air to him about her intentions to never commit suicide.



Narrative:

I was provided with two black American Express appointment books by Det. Cpl. Brockew on 05/07/08. The books are leather bound and measure, approximately, 8" X 10" and there is a gold globe embossed on the front, center, cover as well as the initials "DJP" (Deborah Jean Palfrey) embossed in gold located on the lower right corner of each book. One book has the year 2007 in gold under the said globe and the second book has the date of 2008 in the same location. On the binder of each book the following words are imprinted: The American Express Appointment Book and the year (2007 or 2008) is imprinted below these words. The said books were located in Blanche Palfrey's residence, in the spare bedroom, where Deborah Palfrey would sleep and contained her suitcase and other personal belongings. One book was recovered from the top of a dresser in the room and the other was recovered from the top of an open suitcase also in the same room.

On 05/07/08 I did examine the contents of the said appointment books. I was also provided a copy of Deborah's suicide note to her mother and sister by Det. Cpl. Brockew prior to this examination. A vast majority of both books contain media appearance dates and appointments with attorneys, media producers, etc. The information was hand written in the appropriate date and time slot in the book. The handwriting in the notes left for Deborah's mother and sister is very consistent with the handwriting observed in these appointment books. Professional forensic document analysis on the actual suicide notes will be conducted and the results of the examination will be the subject of a future supplement report filed by Det. Cpl. Brockew.

In the 2007 book I observed the following:

Travel itineraries, including airline ticket boarding passes and hotel reservations, for travel in the following months of 2007: January, February, March, April, May, June, July, August, September, October and December. Business cards for media contacts and attorneys. One small piece of paper with handwritten phone numbers and names. One mini storage contract for a business in Orlando, Florida. One copy of a hand written affidavit signed by Suzanne Irmischer Redfern dated January 12, 2003 and one German real estate flyer appearing to describe an apartment near Berlin and legal documents pertaining to Deborah's federal court case.

The 2008 book contained the following:

Travel itineraries for January and February, directions to attorney's office in San Francisco, the book had dated appearances written in the appropriate dates for various media outlets. The last entry was written in on April 5, 2008. One handwritten request (apparent fax request) to Yvonne Polzin of Deutsch Bank to "transfer/wire all remaining monies from my DB account to:" the Bank of America checking account of Blanche Palfrey. This is consistent with the information contained in Deborah's note to her mother in which she states that there is "little surprise" for you in the BOA account. She instructs Blanche Palfrey to use the monies for final arrangement and various account settlements. The handwriting in this book is also very consistent with the handwriting in the notes to Deborah's mother and sister. A small piece of paper from a pad with the Marriot Towne Place suites hotel logo that have what appears to be the handwriting of Blanche Palfrey that gives instructions for the wiring of money to the Bank of America from Germany, one photograph of Deborah's father, one United Airlines boarding pass dated March 29, 2008 from San Francisco to Denver and then Denver to Tampa. One blank check on the Bank of America account of Blanche Palfrey. The check has "Void" written across the front. Several Marriot Towne Place Suites Motel receipts for the following dates and locations:

04/08-04/13/08- Bowie, Maryland
04/05-04/06/08- Emporia, Virginia
04/05-04/06/08- Savannah, Georgia
04/16-04/17/08- Brunswick, Georgia
04/15-04/16/08- Rocky Mount, North Carolina.

All reservations were in the name of either Jeane Palfrey or J. Palfrey and they were charged to an unknown credit card.

The apparent fax request to Deutsch Bank, the small piece of paper with the apparent instructions and the said blank check were separated from the other said articles in the appointment books and placed in a separate container. The appointment books and the said separate container (paper bag) were placed into TSPD evidence. A copy of this report was forwarded to Det. Cpl. Brockew. No further action.




